## Proceeding of 16th SAC Review meeting of KVK, Purnea held on 7th March, 2025

16<sup>th</sup> Scientific Advisory Committee (SAC) meeting was organized at Krishi Vigyan Kendra (KVK), Jalalgarh, Purnea on 7<sup>th</sup> March, 2025. The event commenced with the lighting of the lamp jointly by Dr. Dilip Mahto, Associate Dean-cum-Principal, BPSAC, Purnea, Dr. K. M. Singh, Senior Scientist and Head of KVK, delegates of Line Department and Progressive farmers of the district. The DEE, BAU, Sabour has joined virtually in this programme and address the meeting and given valuable suggestions on KVK activities.

The Senior Scientist and Head of KVK, Dr. K. M. Singh presented the ATR of proceeding of previous SAC meeting held in June, 2023, as well as the Progress Report of KVK from Jan 2024 to Dec 2024 and Action Plan from Jan 2025 to Dec 2025.

The August gathering discussed on the different Scientific agendas of KVK, Purnea and following decisions have been taken:

- 1. The KVK should prepare quarterly training calendar for conducting capacity building programme more focusing on Rural Youth of the district and circulate to ATMA/DAO Office, Purnea.
- 2. Under the Climate-Resilient Agriculture Program (CRA), emphasis will be placed on promoting climate-resilient crops and short to medium-duration crop varieties.
- 3. The machineries regarding harvesting and processing of makhana should be communicated to makhana growers.
- 4. In view of the excessive use of chemical fertilizer in Rabi Maize, it is suggested to apply balanced use of nutrients.
- 5. The popularization of millets, sweet corn, baby corn should be done amongst the farmers.
- 6. The technology/varieties/bio-fertilizer developed and released by the University has to be promoted in the district.
- 7. Capacity Building-cum-demonstration programme on forage crops for dairy animals should be undertaken.
- 8. The Line Department personnel/Bank Officer should be invited in KVK training programme for addressing the different government schemes for farmers.

At last, the meeting was concluded by vote of thanks by Dr. Govind Kumar to all the dignitaries present in the auditorium.
